## **CHALLENGE**

- Ramos needed to demonstrate strong ownership experience and secure Bosch approval on the property based on location, shop layout and equipment standards
- Launching a new franchise with an unproven track record in the U.S. required innovative loan structuring and flexible working capital solutions
- He required a loan that could simultaneously cover the property purchase, the installation of high-specification equipment and the initial brand ramp-up, all while providing a cash flow cushion
