# FIRST-DAY RENTAL

LeaseCARE provides immediate first-day rental vehicle coverage, up to \$30/day (\$45/day for Lincoln vehicles) for up to 3 days on each eligible repair visit. Plus, there is no deductible!

## ELIGIBILITY

- LeaseCARE can be purchased on any Ford or Lincoln vehicle within the Basic Coverage of the New Vehicle Limited Warranty (3 year/60,000 kilometre, whichever occurs first for Ford vehicles and 4 year/80,000 kilometre, whichever occurs first for Lincoln vehicles).
- Coverage for eligible vehicles begins on the date of plan purchase and ends at the selected time (from Warranty Start Date) or distance travelled (on the vehicle's odometer) limitation (whichever occurs first); time and distance travelled limitations are calculated from the warranty start date and zero kilometres.
